5. Privacy

The City of Owen Sound is committed to providing site visitors with a web site that protects their privacy. The City of Owen Sound respects the privacy of its Internet users and will protect that privacy as vigorously as possible.

Personal Info Collected

The City of Owen Sound web site does not automatically gather any specific personal information from you, such as your name, home phone number or email address. This type of information is obtained only if you supply it by sending us an email or by registering in a secure portion of the site.

All personal information held or collected by the City of Owen Sound is protected under the Municipal Freedom of Information and Protection of Privacy Act. The City of Owen Sound does not collect information that personally identifies individuals except when individuals provide such specific information on a voluntary basis. This information is only obtained if you provide it voluntarily, through contacting us via e-mail, via paper form or through an online form.

Visitors' personal information received via e-mail is provided only to City of Owen Sound staff, who require the information to respond to inquiries. This information is not used for any other purpose. No information sent to the City of Owen Sound via e-mail or the website inquiry form is used for any other reason than to respond to and maintain a record of the inquiry.

Information on individual visitors is used by City of Owen Sound employees who need to know the information in order to respond to your request or to ensure the security of this system. The information is only shared with another department or organization if your inquiry relates to that department or organization. The information is not used to create individually identifiable profiles.

The City of Owen Sound does not sell, trade, or rent personal information to others. The City of Owen Sound may provide aggregate statistics about traffic patterns, and related site information to relevant committees and organizations. These statistics will include no personally identifying information.

Business Directory

The City Business Directory is an on-line database which allows the public to search for products and services in the Owen Sound area. It supports local businesses by providing easy access to the public for business information. The Business Directory also gathers economic development statistics to support the Owen Sound business community. The City offers for sale some of the information collected in the on-line business directory. The information fields that are contained in the directory which is for sale are:

Business Name, Business Address, Business Phone Number, Business Fax Number, Contact E-mail Address, Contact Name, Business Web Site Address, Municipality, Business Type and Business Category

All other fields collected during the registration of a new business in the on-line directory are used only by City staff, to generate Economic Development statistics. Individual businesses are not identified in the presentation of these statistics. Other than the fields mentioned above, the City does not rent, trade or sell business information from the on-line business directory to others.

Network Traffic Monitor

The City of Owen Sound employs software programs to monitor network traffic to identify unauthorized attempts to upload or change information, or otherwise cause damage. This software receives and records the Internet Protocol (IP) address of the computer that has contacted our web site, for the date and time of the visit and the pages visited. We make no attempt to link these addresses with the identity of individuals visiting our site.

Cookies

The City of Owen Sound occasionally uses "cookies" to track how our visitors use this site to determine sites previously visited. The cookies we use do not allow us to identify individuals.

They are compiled into statistical information on traffic patterns and are used to assess site efficiency. The system will notify you before any cookies are used so that you may refuse them providing that option is set in your browser security options. The refusal of cookies will not affect the site performance or restrict your ability to access information from this site. (A "cookie" is a file that may be placed on your hard drive without your knowledge by a web site to allow it to monitor your use of the site).
